- 1. Rate proposals are subject to acceptance within 30 days.
- 2. Rate quotations are based on door-to door service (24 hours advanced notice required)
- 3. The rates are based on minimum density of 10lbs per cubic foot. When it is not possible to load on top of a shipment the cubic dimension for that shipment will be based on 8.5 feet. Shipments occupying 12 or more linear feet of trailer space will be billed at a minimum of 1000 pounds per linear foot at the applicable rate.
- 4. Rates are subject to renewal one (1) year from date of acceptance (unless otherwise specified in the rate proposal). The continued application of rates is conditional on account being in good standing at all times.
- 5. Rates are subject to applicable fuel surcharge unless otherwise stated.
- 6. Rates are quoted in Canadian funds unless otherwise stated.
- 7. Rates quoted in U.S. funds will be subject to a periodic review in the absence of a currency surcharge.
- 8. All shipments are subject to the Bill of Lading Conditions of Carriage. All shipments require a bill of lading with all pertinent information (ie: shipper's and consignee's full name, address, phone numbers, prepaid/collect or third party billing, numbers of piecesskid/carton etc, total weight/cube, appointment time and any other special pickup/ delivery instructions.
- 9. Declared value on the bill of lading in excess of \$2.00/lb will have additional charges assessed.
- 10. Claims and Liabilities: for loss, damage or shortage of any goods carried under the bill of lading unless notice of same is clearly indicated on the bill of lading at the time of delivery. The intent to claim must be filed within sixty (60) days and the statement of claim must be filed within nine (9) months from the date of shipment. A copy of the paid freight bill must accompany the claim. Liability of (\$2.00/lb) applies only to the damaged and/or missing portion of the shipment, not the entire shipment.
- 11. Carrier is not liable for any cost of non-compliance penalties arising from late deliveries, shortages etc.
